# QUALITY MANAGEMENT REPORT (D 2.2)

**Aims:** to explain the quality assurance procedures that the REMOR Project will put in place in order to ensure that the Project's output complies with standard and best practice.



### INTRODUCTION

The quality assurance procedures that the REMOR Project has put in place in order to ensure that the Project's output complies with standard and best practice, in this **Interim Quality Management Report (D 2.2)**, centre upon strict monitoring of the activity carried out in relation to each Work Package assigned to the Partners, as established in the **Implementation Plan (D 1.2)**, and upon the respect of all deadlines (as set out in the **Implementation Plan (D 1.2)**), for the completion of tasks and presentation of results thereto associated in relation to the same Work Packages.

Each of the seven parts of this **Final Quality Management Report (D 3.2)** provides the European Commission and all the Partners involved with an overview of the activities /tasks and deliverables which were held / submitted from the beginning of the REMOR Project to January 2008 in furtherance to the completion of the REMOR Project.

As will be shown by the reports included herein, the Work Packages assigned to the Partners have been, in general, adequately processed and have delivered appreciable middle-term results; each Report outlines the activities carried out by those involved in the performance of the relative Work Package.

It is also to be noted that this **Interim Quality Management Report (D 2.2)** is being delivered past the deadline due to a temporary suspension of relations with the Chamber of Advocates, Malta following the recent renewal, by election of its Board of Directors, which Board has affected changes in the persons responsible for the REMOR Project.

The following Reports outline in further detail the activities carried out by the Partners with reference to each Work Package.



# **WORK PACKAGE 1 - MANAGEMENT**

### UNIVERSITY OF GENOA - GIOVANNA SAVORANI

**Aim**: to promote communication and cooperation among Project participants and to monitor the progress of the Project.

**Step 1**: planning and organisation of the **Kick-off meeting (D 1.1)**, held in Genoa, in April, 2007.

The meeting was aimed at introducing the Partners, at highlighting the main objectives of the REMOR Project, at identifying the best approach strategy for the attainment by all Partners of the same objectives, at allocating the responsibilities of each Partner to the REMOR Project (inclusive of the allocation of activities, tasks and deliverables), and at explaining the European Commission budget allocation between the Partners. Representatives from the University of Genoa, the National Association of Romanian Bars and the Bar of Genoa attended the meeting and all the aims above-listed were successfully attained.

The Partners present agreed upon:

- the content of the **Implementation Plan (D 1.2)**;
- the necessity to provide reciprocal information on specific national legislation and jurisprudence concerning maintenance obligations recovery to this purpose the University of Genoa has set up the Standard Questionnaire for REMOR Partners, inviting the same to provide a reply thereto;
- the necessity to create a network of contacts among all Partners, for the mutual exchange of information and opinion – to this purpose the Partners agreed to affect monthly conference calls via Skype technology.

The University of Genoa further proposed the set-up of a *forum* within the REMOR web portal in order to facilitate the exchange of information on each national legal system and legislation relative thereto, and to promote regular contact among the Partners. The proposal was to be further considered once the REMOR web portal was set up.



The **Project Presentation** is being herewith attached as <u>Appendix No. 1</u>.

**Step 2**: drawing up of the **Implementation Plan (D 1.2)**, delivered in accordance to deadline, in April, 2007. It is aimed at providing all REMOR Project Partners with the necessary guidelines for the performance of the tasks required to be fulfilled by each of the same and to achieve the objectives and the results expressly indicated in the Grant Agreement with the European Commission.

# The **Implementation Plan (D 1.2)**:

- provides a description of the Kick-off meeting (D 1.1) [vide Step 1 above];
- details, by way of numbered Work Packages, the activities and tasks to be performed and the deliverables to be delivered by each Partner, in order for the same to produce the results specifically thereto assigned, together with the deadline for the same performance and delivery;
- details the Standard Questionnaire for REMOR Partners;
- provides a timetable of activities, tasks and deliverables to be performed by each Partner in view of the successful outcome of the REMOR Project;
- also provides, in the form of annexes thereto, the scheme of the REMOR Project timetable and the REMOR Project contact form to be filled-in by the Partners and returned to the University of Genoa.

The **Implementation Plan (D 1.2)**, together with its two annexes respectively referring to the **Time Grid** and **Contact Form** is being herewith attached as <u>Appendix No. 2</u>.

**Step 3**: follow-up of the activities carried out by each Partner in accomplishing the aims specified in the **Implementation Plan (D 1.2)** together with the mutual exchange of opinion.

It must here be noted that the University of Genoa has followed up the said activities, as performed by each of the Partners and as outlined hereunder, in a meticulous manner, which in turn highly contributed to the successful outcome of the REMOR Project.

**Step 4**: drawing up and delivery of the **Interim Report (D 1.3)**, delivered in accordance to deadline [as extended], in November, 2007.



The **Interim Report (D 1.3)**, describes all the activities performed within the REMOR Project from the beginning of the same to the date of the said Report, that is, November, 2007. It details all the steps of the various Work Packages assigned to the Partners, and which are deadlined by November, 2007. It also places specific focus upon the learning activities undertaken by the Partners and to the results and reports thereof.

#### WORK PACKAGE 5 - PREPARATION AND REALIZATION OF SEMINARS AND STUDIES

# RIGA SCHOOL OF LAW - PETER GJOERTLER

**Aim**: to identify and select legal practitioners together with the most appropriate learning materials for the lessons; to organise, schedule, plan and realise seminars and lectures, and to experiment in video-streaming the same.

First and foremost it is to be noted that Anders Fogelklou, originally indicated as the selected coordinator of this particular Work Package in the **Interim Report (D 1.3)** is no longer in the employment of the Riga Graduate School of Law. As such his colleague, Peter Gjoertler, has accepted to substitute Anders Fogelklou as coordinator of this particular Work Package.

**Step 1**: drawing up of the **Rules for the selection of Legal Practitioners (D 5.1)**, delivered in accordance to deadline [as extended], in January, 2008.

The Rules for the selection of Legal Practitioners (D 5.1) are being herewith attached as <u>Appendix No. 7</u>. The said document explains how the aim of the REMOR Project has been to bring attention to the national rules and how the same interface with the legal system of other Member States, so as to achieve both an understanding of the reach and limitations of the available European Union instruments, as well as to give rise to a reconsideration of the principles underlying the national systems. In this connection, it explains how maximum regard was given in the drawing up of the Rules for the selection of Legal Practitioners (D 5.1) so that the project reach out not only to legal practitioners in the traditional sense of practicing lawyers registered at the national bars, but also to other practitioners, including those in public service, as well as law makers and academics.

**Step 2**: selection and preparation of the **Learning Materials for the REMOR Project Seminars (D 5.2)**, delivered in accordance to deadline [as extended], in May, 2007.

In view of the above deliverables, The Riga Graduate School of Law has carried out preliminary activities, amongst which arranging rules for the selection of legal practitioners for the REMOR Project seminars. With regard to the latter and to each of the REMOR Project seminars held, it has been agreed that the Partners responsible for the same are to, select and prepare own learning materials, organise and schedule their



own timetables, prepare a report on the said activity, each of which is then to be passed on to the Riga Graduate School of Law as coordinator of this Work Package.

The Learning Materials for the REMOR Project Seminars (D 5.2) are being herewith attached as Appendix No. 8.

May it be additionally pointed out that the REMOR web portal <a href="www.remor.cc">www.remor.cc</a> includes a compendium of all relevant acts concerning judicial cooperation in civil matters, as the basis of information with regard to the specific initiatives being taken by the European Community with regard to Family Law in general, and with regard to maintenance obligations recovery in particular.

The procedure as outlined above has been successfully put into effect as agreed upon and duly followed by:

**Step 3**: **Organisation and Scheduling of Courses (D 5.3)**, completed in accordance to deadline, in June, 2007.

### **WORK PACKAGE 6 - EVALUATION**

The **Evaluation Plan (D 6.1)** explains the criteria to be utilised for the evaluation of the achieved outcomes of the REMOR Project. It also contains those criteria to be utilised for the evaluation of the quality of the products of the learning and research activities, for the evaluation of the participation in the REMOR Project, for the quality of the performance of the tasks assigned to each Partner and for the general impact of the same Project. The External Committee (D 6.1), on the basis of the data collected, is to evaluate the quality and relevance of the REMOR Project by the 31st of March, 2008, by considering the degree of involvement and participation of the Partners and/or of other academic



and professional institutions. All the Partners have agreed to supply the said **Evaluation Committee (D 6.1)** with all the documentation necessary and useful to its assessment exercise.

**Step 2**: drawing up of the **Evaluation Report (D 6.2)**, delivered in accordance to deadline, in January, 2008.

The **Evaluation Report (D 6.2)** points out the method and criteria followed in evaluating those activities carried out in the execution of the REMOR Project and specifically of the tasks assigned to each of the Partners and the results achieved in connection thereto. It also assesses the REMOR Project in an overall manner.

In this connection the National Association of Romanian Bars has been assisted by the other Partners in the evaluation process, in that the said Partners have provided all necessary information upon request.
