- Dr. Radu Bogdan Bobei Attorney at law from the Bucharest Bar and lecturer at the Bucharest University, Faculty of Law. Mr. Bobei delivered two presentations in connection to the following: (i) Maintenance obligations in the Romanian Law. The European legal system perspective (ii) International Conventions in the field of maintenance obligations.
- Mr. Constantin Voicescu Attorney at law from the Bucharest Bar. Mr. Voicescu made a presentation of the following: Appliance of the New York convention in the field of maintenance obligations in the practice of the Bucharest Bar. Actual and future problems.

Also, I have made a presentation about the REMOR Project as a whole, about the implications of being a partner in a European project and more specifically about the objectives of the REMOR Project. I have presented the deliverables achieved by the REMOR Project and the benefits of its implementation.

The Seminar has been conducted in an interactive manner which implied that the participants were able to ask questions to the lecturers and also to make statements of their own if they wished to do so.

The REMOR Seminar organized by N.A.R.B. in Romania permitted the Romanian legal practitioners to get acquaintance of the newest developments in private international law and community law. Also, it offered them the possibility to benefit from the experience of their lecturers who, faced with different situations in their attorney practice, have developed adequate responses to these impasses.

Also, participants benefited from the knowledge of a person involved in psychology, and thus have been informed on the impacts that divorce and late or non payment of maintenance obligations have on the development of children. These information generated discussions among the participants who were willing to inform their future clients on the psychological implications in discussion.

In the end, the discussions shifted towards the future use of mediation in family disputes. These discussions were generated by the recent



entering into force of law no. 192/2006 regarding the mediation procedure.

It is to be mentioned that participants to the seminar have been given the printed version of the Microsoft Power Point Presentation realized by the lecturers. Thus, the participants have been able to follow in depth the lectures and to formulate questions and statements.

In conclusion I would like to inform you and all partners that the REMOR Seminar organized by N.A.R.B. has constituted a success from several points of view, but most of all because of the fact that the participants have gained a practical knowledge which they are going to use in their daily work.
